What is AMI F?

The African Military Law Forum (AMLF) is an organization composed of dedicated African legal professionals serving in the military or working in the Ministry of Defense or Ministry of Justice. The goal of AMLF is to bring together African military legal advisors from 54 African Nations to discuss legal topics of interest, propose model solutions, and exchange ideas on how to improve military operational adherence to the Rule of Law. AMLF was initiated in March 2014 in Malawi as a forum to gather senior level African military legal advisors from across the African Continent. Subsequent AMLF General Meetings were held in Stuttgart, Germany in 2015, Accra, Ghana in 2016, Oberammergau, Germany in 2018, and Sanremo, Italy in 2019. AMLF is co-sponsored by the United States Africa Command (USAFRICOM).
