







# Legal Finish Initiative

**Phoenix Express 2022** 

Tunis & Bizerte, Tunisia



## I. Initiative Overview

From 25 to 29 May 2022, maritime and legal subject matter experts from the United States, Tunisia, and Morocco supported the Phoenix Express 2022 (PE22).<sup>1</sup> Legal Finish Initiative through maritime legal information exchanges. The ultimate goal of the Initiative was to promote military-civilian mutual understanding and cooperation along the maritime "collection to courtroom continuum." To achieve this objective, engagements focused along two lines of effort: (1) increasing appreciation among maritime boarding teams of their important role in preserving and promoting the prosecutorial option and (2) fostering greater understanding among judicial actors of the challenges faced by maritime security forces engaged in interdictions at sea.

This inaugural Legal Finish Initiative was facilitated by the USDOJ OPDAT Justice Programs Advisor to U.S. Africa Command (USAFRICOM) with the support of USAFRICOM's J59, U.S. Naval Forces Europe and U.S. Naval Forces Africa (NAVEUR-NAVAF), the Defense Institute for International Legal Studies (DIILS), and the UNODC's Global Maritime Programme

The PE22 Legal Finish Initiative was carried out through a series of exchanges between a team of civilian legal experts (the "Legal Finish Team") and navy and coast guard members participating in PE22 as boarding teams, planners, and members of the maritime operations center (MOC) and the exercise control group (ECG). The Legal Finish Team was composed of a district attorney and an attorney general from Tunisia, two judges from Morocco, and one law enforcement officer from Tunisia and one from Morocco. In addition, six Tunisian military legal professionals (three operational legal advisors (LEGADs) and three military magistrates) augmented the Team during several of the Legal Finish events.

Over the course of the week, the Legal Finish Team briefed over 150 members of participating navies and coast guards on recent regional maritime crime trends, contributed legal perspectives during a tabletop exercise (TTX), and shared best practices for facilitating the prosecution of nefarious actors during interdiction operations. The maritime security forces were thrilled to have this unique opportunity to

interact with the judges and prosecutors handling the cases of those they detain. The Legal Finish Team, in turn, benefitted from this time to focus on maritime law enforcement operations. They received briefings on maritime law and maritime operations, observed their nation's maritime forces exercising interdiction operation techniques, and listened to navy and coast guard participants describe the dangers attendant inspection and interdiction missions and how the dynamic nature of those operations affects evidence collection.



The program was a huge success, with both maritime security forces and the civilian justice representatives requesting the continuation and expansion of the program for next year. The members of the Legal Finish Team, who had no specialized maritime training before participating in the Legal Finish Initiative, recommended that the United States continue to support maritime law programs throughout the year and expand the Legal Finish Initiative for PE23.<sup>2</sup> The Legal Finish Team members reported that insights gained over the course of the Legal Finish Initiative would inform their work as they investigate and prosecute

cases and draft domestic maritime legislation in the future. The navy and coast guard members participating in the Legal Finish Initiative expressed a new appreciation for the importance of their actions (before, during, and after operations) to the ultimate prosecution of nefarious actors. All parties agreed that increased military/civilian coordination and communication leading up to, during, and following maritime interdiction operations are the keys to bringing down criminal networks and improving judicial results.

Topics identified for future engagements: international and domestic laws and their application to realworld maritime operations; the relationships between naval special forces boarding teams, coast guard teams, and traditional law enforcement units; the linkage of international standards for boarding and inspecting vessels with domestic search and seizure laws; the responsibilities of and relationships between maritime security forces, law enforcement, judicial police, and prosecutors.
